

Notification Form for the Processing of Personal Data for the Trust Unitholders' Meeting

Frasers Property Industrial REIT Management (Thailand) Company Limited (the “Company”), acting as the REIT manager of Frasers Property Thailand Industrial Freehold & Leasehold REIT (“FTREIT”), values the importance of personal data protection and therefore, has established and hereby notifies you of the guidelines regarding the personal data processing in relation to the Trust Unitholders' Meeting No. 1/2026 of FTREIT, through electronic media (E- Meeting) “Trust Unitholders' Meeting”, to explain the methods and purposes for which your personal data will be processed, in compliance with the Personal Data Protection Act B.E. 2562 (2019) (PDPA). The details are as follows:

Personal data to be collected, used, disclosed and/or stored

The Company will collect, use, disclose and/or store (“Process”) your general personal data, including that of the proxy holder (if any), i.e., name-surname, date of birth, identification number/passport number, trust unitholder identification number, address, telephone number, email (if any), photos including video recordings on the Trust Unitholders' Meeting.

In this regard, the identification documents submitted to the Company, such as the copy of the identification card or other official documents may contain sensitive personal data e.g., race, blood type or religion, which are not required for the purpose of convening the Trust Unitholders' Meeting. You may blaken those data prior to submitting the documents to the Company. In the event that you did not blaken such sensitive personal data, the Company reserves the right to blaken out those sensitive personal data received, whereby such action shall not be considered as the Processing of your sensitive personal data.

Sources of the Personal Data

The Company may collect your personal data from the following sources:

1. Collected directly from you from the information which appeared in the registration documents to attend the Trust Unitholders' Meeting and the Proxy Form (if any)
2. Information which appeared in the list of trust unitholders of FTREIT as of the date for the determination of the trust unitholders entitled to attend the Trust Unitholders' Meeting (record date) which the Company received from Thailand Securities Depository Company Limited (TSD) as the registrar of the trust units.
3. Collected from the photos and video recordings which were recorded throughout the Trust Unitholders' Meeting.

Purpose and Necessity of the Personal Data Processing

The Company is required to collect your personal data for the following purposes:

1. Identification of the rights of the trust unitholders to attend the Trust Unitholders' Meeting, the convening of the Trust Unitholders' Meeting, the acceptance of the registration to attend the Trust Unitholders' Meeting, the counting of the quorum and the counting of votes.
2. Preparation of the audio and video recording system throughout the Trust Unitholders' Meeting.
3. Recording of your name-surname in the meeting minutes (in the event that you express your opinion and/or inquire during the meeting). In this regard, the meeting minutes will be disclosed through the website of FTREIT, as well as submitted to the Stock Exchange of Thailand and the relevant regulatory agencies as legally required.

Period of Personal Data Retention

The Company shall retain your personal data for the performance of the purposes specified in this document for the duration necessary and as required by the applicable laws and regulations, in order to comply with the objectives of holding the Trust Unitholders' Meeting. After such period, the Company shall retain your personal data as backup information for reference and verification in case of necessity for 10 years from the date of receipt of your personal data, except as otherwise required by the law.

Data Subject Rights

You, as the data subject, are entitled to withdraw the consent given for the Processing of personal data, however, the withdrawal of consent shall not affect the Processing of any personal data which has already been consented. In addition, you have the right to request the access to your personal data, the right to request a copy of your personal data, the right to receive your personal data, the right to request for the transfer and relocation of your personal data to another data controller, the right to object to the Processing of your personal data, the right to request the deletion or destruction of your personal data, the right to request the suspension of the use of your personal data, the right to request the correction of your personal data and the right to file a complaint against the Company with the Data Protection Committee.
